The UAPFO this year distributed 25,000 seedlings to its members. The association has also begun to charge for membership fee for its members with a minimum fee of 2 euros. There were held three informal meetings that were attended about 200 PFO where seedlings were distributed and was discussed about service provision.

REPORT ON MICRO-GRANTS

ALBANIA

'Family forestry as a key factor for rural development' Project

Supported by SSPDF Project under the micro grants, NFCFP Albania implemented a project, whose main goal was to influence the decision makers in taking the right decision in benefit of rural families related to law on forest and pastures. The other goal was to promote family forestry in Albania through acknowledgment of family forestry models and the best practices from the region (Kosovo and Macedonia). Since the new draft law on forests and pastures was at the final phase, NFCFP held a meeting on March 10, 2016 with the Head of the Parliament Commission of Productive Activities, Trade and Environment, Mr. Eduart Shalsi and two parliament members (Mr. Besnik Baraj and Mr. Namik Kopliku). The main discussion topic was the rights of forest and pastures user families and the roles of CFPUAs which were not reflected as it should in the new draft law on forest and pastures. Among others during discussions NFCFP brought up the best models of family forestry from the country and the region and the parliament members were invited to see in the field concretely and for this it was agreed with them to do a field visit. On March 18, NFCFP organized the field visit in Zall-Dajt village (Tirana district) where the three parliament members were present. They saw by close the reality and the model of family forestry, where to their frequent questions were answered directly by forest user families.

Another activity in the framework of this project was the field visit in Has and Radomire during 5-6 May 2016. The aim was to promote the experiences of protection and traditional management of forests by local community. Representatives from NAPFO Macedonia and Kosovo participated in this activity and brought the experiences from their respective countries. The number of participants in this two-day field visit was 86 people, where 16 of them were women.

During June 2016 is made dissemination of results via social media, email and it is prepared the report. For implementation of all project activities are spent 12 LCB days.

Achievements:

- The parliament members took into consideration the rights of forest user families and CFPUAs and the existing new draft law on forest and pastures was postponed to be reviewed.
- Shared experiences on management of family forest among three REFORD member associations;
- Shared experiences on certification of forest users in Malzi, Kukes;
- Cultivation of forest fruits in Golaj (Has) and transferring of cultivation technology from Kosovo to Albania;
- Acknowledgment with the tradition of collective use of forests in Radomire (Diber);
- Promotion at national and regional level the experiences of protection and traditional management of forests by local community through a TV documentary from a National TV channel (Top-Channel).
- Sharing of experiences with REFORD members via other communication means.

MACEDONIA

"Increasing capacities and cooperation among members of REFORD network" Project

The Project under micro grants "Increasing capacities and cooperation among members of REFORD network" aimed at supporting solution of the confusing situation with representation of PFOs from Bulgaria and reinforcing its network and representation. The main goal was to improve the organizational structure of all private forest owners in Bulgaria.

For this project took more days to organize meetings and project management activities (for the entire duration of the project (2 + 2 days) that were to be implemented in Bulgaria for several reasons pertaining to the importance of action on the whole territory of the Republic of Bulgaria; the importance of opening of branches throughout the Republic Bulgaria, making REFORD more acknowledged and informing about the opportunities and benefits of being part of REFORD network and also introduction of REFORD to state administration of the forestry sector in Bulgaria.

Conducting meetings or conduct meetings consisted of 4 days (2 times in 2 days - 01-02.04.2016 in Chepelare and Bulgaria 14-15.04.2016 in Hisarija Bulgaria).

The meetings (the first part 01-02.04.2016) was attended by all members of NAPFO Bulgaria. Representatives of Macedonia NPAFO ie REFORD were introduced by NAPFO Bulgaria for their organization, their goals and ways of their activities. Members of cooperatives in which the joint owners of private forests and all these cooperatives are united in NAPFO Bulgaria, but currently operate only in the Rhodope mountain around the town of Smolyan.

From representatives of NAPFO Macedonia focused on the positive experiences from Macedonia NAPFO of their actions in the Republic of Macedonia and the positive experiences and objectives of the actions of REFORD.

The second part of the meeting (14-15.04.2016 in Hisarija Bulgaria) From representatives of NAPFO Macedonia before representatives of the state administration (Ministry for Food, and Forestry -IAG) was presented REFORD, its history, members, positive experiences and vision and objectives that it has.

For implementation of all project activities and reporting were spent 12 LCB days. Conclusions derived are as following:

- 1. Out of NAPFO Bulgaria overcame the current territory of action, namely the establishment of branches throughout the Republic of Bulgaria;
- 2. Sought help from Macedonia and NAPFO REFORD in assisting with their own positive examples of organizing branches
- 3. Taking advantage of common opportunities (IPA programs, Donors, sharing experiences, etc.).
- 4. Increased visibility of REFORD organization.

CROATIA

Promotion of rural development program measures for private forest owners

Project report

Most of the private forest owners in Croatia belong to old age groups population and it is necessary to encourage them to apply projects and use the possibilities from RDP.

Private forest owners need to be more educated and informed about the possibilities to use subsidies from RDP. RDP measures are defined to improve forest and private forestry regardless of project applicant.

According to the proposed plan next activities were conducted in order to implement project:

- 1. On 1/2/2016 half day preparation meeting in Zagreb. Participant: Zdenko Bogović, Domagoj Troha and Miljenko Županić from CROUPFOA and Robert Ojurović, assistant director of Advisory service. Conclusions were that stakeholders are very interested to participate on the workshops and it will be necessary to have more than three planned workshops. The costs of additional workshops will be covered by CROUPFOA. On this meeting also was agreed the content of the presentations:
- Introduction in actual situation of private forestry in Croatia with the overview of situation in SEE region (REFORD);
- RDP forestry measures –developing, objectives, applicants, project preparations
- Cooperation in SEE region and possibilities for implementation projects under the REFORD network.
- 2. After this meeting a pttx presentation was prepared. In preparation of the workshops local PFOA-s was involved and encouraged to participate.
- 3. First two workshops were held in Zadar (50 participants) and Šibenik (25 participants) on 5/2/2016. During the conference 'Future of forestry and wood industry in BIH', which was held in Kupres, meeting with representative of NAPFO BIH (Duško Topić) was held on which joint activities was discussed. Third workshop was held in Vela luka on 17/3/2016 (22 participants). Fourth workshop was held in Lepoglava on 31/3/2016 (33 participants) on which the representatives from NAPFO BIH (Duško Topić, Goran Ljubojević and Miro Božić). The fifth workshop was held in Gospić on 22/4/2016 (30 participants).
- 4. During the preparation and after the workshops information about the workshops and results were spread on CROUPFOA website and trough reports and articles on Advisory service website and newsletter. Colleagues from NAPFO BIH also prepare report about the workshop and publish it on their website.
- 5. During the May and June final report was prepared.

During the project implementation participants of the workshops was informed about the REFORD network and encouraged to participate in preparation of joint projects. Project results with significant number of private forest owners or other eligible applicants (licensed companies) who received most important information for preparing and implementing projects under the RDP scope. Implementation of RDP projects could significantly improve situation in private forestry.

For implementation of all project activities and reporting, 12 LCB days were spent.

OVERALL CONCLUSIONS

After implementation of all planned activities according to the respective contracts for each REFORD member associations can be concluded as following:

- 1. Selected economic services by REFORD member associations and implementation at their respective countries has begun;
- 2. Jointly lobbied and advocated at relevant institutions for inclusion of forestry in Rural Development measures and legal reform in the forestry sector;
- 3. Increased networking and cooperation between REFORD member associations;
- 4. Forestry planning process in REFORD member countries reviewed and experiences shared among members;
- 5. Increased acknowledgement of REFORD Organization and family forestry in the Balkan region and beyond.
